
No. 24/1/1-2/07-DE(S)Vol-IV/2: Whereas, **Shri P. Messengeorge Dangshawa, son of Shri Kodar of Khukarthil Village near Kangshang SBI, Chandel district** was appointed as Primary Teacher (SSA), on the recommendation of the Class-III DPC held on the 26<sup>th</sup> February, 2012, and posted at the Thumtam Lower Primary School, Chandel district vide Government Order No. 4/18/2012-SE(S) dated the 25<sup>th</sup> September, 2012.

2. Whereas, the Department of Education(S), Manipur became suspicious that **Shri P. Messengeorge Dangshawa**, Primary Teacher (SSA) of Thumtam Lower Primary School was also undergoing MBBS Course at the Jawaharlal Nehru Institute of Medical Sciences, Porompat while being employed as a Primary Teacher (SSA) at the same time.

3. Whereas, on seeking information on whether the said **Shri P. Messengeorge Dangshawa**, Primary Teacher (SSA) is undergoing MBBS Course at Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Porompat, the Dean (Academic), JNIMS, Porompat confirmed that **Shri P. Messengeorge Dangshawa has been a regular student since his admission into MBBS course in the Institute on the 25<sup>th</sup> August, 2012. He appeared all the Professional Examinations and passed the examinations and presently he is doing his One Year Compulsory Rotatory Internship w.e.f. the 28<sup>th</sup> August, 2017** vide their office letter No. JIMS/Academic.3(5)/Corresp/12/1376 dated 04/01/2018.


4. Whereas, the said **Shri P. Messengeorge Dangshawa** was found to be already pursuing MBBS Course at Jawaharlal Nehru Institute of Medical Sciences, Porompat (since his admission to the MBBS course on 25/08/2012) before appointment as Primary Teacher (SSA) under the Department of Education(S), Manipur on 25/09/2012, the appointment of **Shri P. Messengeorge Dangshawa** is treated as *null and void*.

5. Now, therefore, the appointment of **Shri P. Messengeorge Dangshawa** as Primary Teacher (SSA) under the Department of Education (S), Manipur issued vide Order No. 4/18/2012-SE(S) dated 25/09/2012 is hereby **cancelled**.

6. It is, therefore, ordered that Zonal Education Officer (Chandel), Government of Manipur shall lodge an FIR against **Shri P. Messengeorge Dangshawa, son of Shri Kodar of Khukarthil Village near Kangshang SBI, Chandel district** for alleged fraudulence and wrongful drawal of pay and allowances etc. under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the Zonal Education Officer (Chandel), Government of Manipur shall recover the pay & allowances wrongfully drawn by **Shri P. Messengeorge Dangshawa** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
