No: 2/1-2/2008-ED(V): In pursuance of the Govt. approval conveyed under Letter No.33/41/2013-SE(H/S) dated 20/05/2014, it is hereby notified for general information that a **new joint admission system** in Class – XI as detailed below shall be introduced in respect of the following Govt. Hr. Sec. Schools located in and the around Imphal, w.e.f the current academic session (2014-15).

1. The following 8 (*eight*) Govt. Hr. Secondary schools shall be covered under the proposed scheme/system of admission.

2. Seat shall be reserved for the ST/SC/OBC/PH students as per existing reservation rules.
3. Each school shall be allowed to offer certain combination of subjects by taking into account the availability of the concerned lecturers as well as sufficient space/room.
4. There shall be common cut off mark for all schools in respective streams namely Science, Arts and Commerce.
5. A common Admission form shall be issued by the Directorate on-line free of cost w.e.f 22<sup>nd</sup> May, 2014 and each school shall be the collection centre of the duly filled in Forms.
6. The last date of submission of duly filled in forms at the collection centres shall be 31<sup>st</sup> May, 2014.
7. Each applicant student shall however be charged with an admission processing fee of Rs. 100/- (*Rupees one hundred*) only to cover the expenses incurred in arranging this new system of admission.

8. All admission forms shall be processed in the Directorate and allocation of students to these 8 (*eight*) schools shall be made as per merit list prepared on the basis of marks secured in the HSLC or equivalent examination, and by taking into consideration the preference of the students as well as reservation of seats for SC/ST/OBC/PH students. If the need arises counseling will be held for equitable allocation of students to respective schools. The Deptt., however, reserves the right to allocate the students to any of the schools for reasons to be recorded.
9. There shall be a common admission fee structure for all the selected schools.
10. Issue and collection of admission forms shall be completed by the month of May and processing for selection and allocation of students to the schools shall be completed by the 15<sup>th</sup> of June, 2014.
11. Notification for selection and allocation of schools will be notified by the Directorate of Education on the 16<sup>th</sup> of June, 2014 or next working day.
12. All admission processes for the allocated students should be completed by the concerned schools by the 30<sup>th</sup> of June, 2014 in order to comply with the School Academic Calendar already notified by the Govt.
