Sir/Madam,

Fund amounting to a total of Rs. 1,14,82,819/- (Rupees one crore fourteen lakhs eighty two thousand & eight hundred nineteen) only is hereby allocated for payment of salary to Approved Teachers of Grant-in-aid Secondary Schools (under Non-Plan) for the period from 01/07/2014 to 31/10/2014 as detailed in the Annexure under the following Head of Accounts:

- 2202- General Education (Non-Plan)
- 02 - Secondary Education
- 110 - Assistance to Non- Government Secondary Schools
- 05 - Assistance to Non- Government Secondary Schools
- 01 - Non-Govt. Secondary Schools
- 31 - Grant-in-aid

2. The allocation is made in exercise of the powers delegated under item No. 7 of Schedule -III(Education Department) of the Delegation of Financial Power Rules, 1995 as amended vide Notification No. 1/2/2001-FX(EXP) dated 12/05/2014 of the Secretariat: Finance Department (Expenditure Section), Manipur and the relaxation of requirement of certified list of employees and sanctioned strength of Grant-in-aid Schools for drawal of pay and allowances of the approved teachers upto the month of October, 2014 vide letter No. 2/3/2013-MIS(CONREX) Dt. 24/9/2014.

3. Future allocation of fund for payment of salary to approved teachers of Grant-in-aid schools shall be subject to issue of list of employees and sanctioned strength of these schools certified by the Director of MIS, Finance Department, Manipur.

4. It is further to add that the sanction/ release of Grant-in-aid to the Aided Schools shall be subject to fulfillment of all eligibility criteria and terms& conditions laid down in relevant rules for claiming the grant.






5. The Concerned DDOs should maintain absolute financial propriety and ensure that no excess payments are made in any manner as warranted under relevant rules.
