NO.2/331/2015-ED(S)Pt: It is hereby notified for information to all the Graduate Teachers, whose names and particulars appeared at serial No. 261 to 375 of the final seniority list of Graduate teachers as notified vide Notification No.46/52/2010-ED(V) dated 15/06/2012 that a writ petition being W.P(C) No.555 of 2015 has been filed before the Hon'ble High Court, Manipur praying, inter alias, for setting aside the said impugned final seniority list of Graduate teachers.

And the names and particulars of those Graduate Teachers, who have been impleaded as party Respondents No. 3 to 117, may be seen from the official Web Site of the Department(www.manipureducation.gov.in).

And the Hon'ble High Court has intimated the undersigned for causing service of the summons upon the said Graduate Teachers(one hundred and fifteen in number) vide their letter No.HCM/WP(C)/555/2015 dated 24/7/2015. Hence, all the said Graduate Teachers/Respondents are hereby informed to make their appearance in person or by a pleader before the Hon'ble High Court and contest the same. And copy of the said writ petition may be collected from the Department during the office hour.
