1. Applicant should fill up all columns in the application form in his/her own handwriting.
2. The application form should be filled in **Capital letters** only.
3. Column No. 1: Name of the applicant should be written in full including surname as appeared in Matriculation Certificate.
4. Column No. 2: Name of the father or husband should be written in full.
5. Column No. 3: Write the sex clearly as male or female.
6. Column No. 4: Write the date of Birth clearly (DD/MM/YYYY).
7. Column No. 6 and 7: Write full present and permanent postal address including house number, street name, area name, village, circle and district including postal pin code & contact no. for future correspondence.
8. Column No. 9: All applicants should indicate their categories (whether belonging to Unreserved/OBC/ST/SC) by putting tick mark in the space/box provided. If any applicant fails to tick mark, or fails to enclose attested photocopy of community certificate, he/she will be treated as Un-reserved. No further claim will be entertained after last date of submission of application from applicants. Applicants belonging to OBC category should enclose certificate which is issued on or after 01-04-2016. Candidates belonging to Physically handicapped category should also indicate whether they belong to Un-reserved or ST or SC or OBC.
9. Column No. 10: Applicant claiming reservation under Physically challenged category should indicate whether they suffer from Orthopaedic or Visual or Hearing disability by tick marking in relevant column.
10. Column No. 11: Applicants should indicate whether he/she is a Govt. employee at present. If yes, "No Objection Certificate" from the competent authority should be enclosed in Original.
11. Column No. 12: Applicants should indicate is field of sport/event
12. Column No. 13: Applicants should filled in Educational Qualifications so far acquired/achieved
13. Column No. 14: Applicants should filled in Sport achievement /awards received.
14. Applicants should affix recent passport size photograph with self attestation.
15. Applicants should submit copies of relevant certificates and marks sheets and sport achievement certificates/awards as proof of their claim and are required to produce respective **certificates in original** for verification at the time of Form submission.
