ORDERS

Imphal, the 15thDecember, 2016

No: AO/65/AMS/2010-DE(S): Whereas under Government Notification No. 12(HC)/361/2006-SE(S) dated 13/04/2010, applications in plain paper were invited from the intended sports persons for recruitment of 20 (twenty) Primary Teachers under Meritorious Sports Person Scheme in terms of OM No. 9/1/83-DP dated 17/10/1998.

2. And, whereas 325 (three hundred and twenty five) applications were received by this Directorate to the effect a Notification of even number dated 01/06/2010 was issued with details of each applicant thereby inviting claims and objections thereof.

3. And, whereas while disposing of the W.P.(C) No. 789 of 2007 and its analogous writ cases, the Hon'ble High Court directed the authorities to consider the claim of the petitioner along with other eligible sports persons for appointment under 5% quota to various posts available under the state of Manipur under the relevant recruitment rules in accordance with law.

4. And, whereas certain clarification including one time age relaxations for applicants who have already submitted their applications in view of the various Court Orders and pending cases had been sought from the Government under this Directorate letter of even number dated 5th July 2016.

5. And, whereas in reply to this Directorate letter of even number dated 5th July 2016 as referred herein above, approval of the Government was conveyed for appointment of Meritorious Sports Persons against the 20(twenty) posts of Primary Teachers which was notified vide Notification No. 12(HC)/361/2006-SE(S) dated 13/04/2010 and the written test to be conducted in view of the OM No. 1/22/2005-DR-III-DO dated 17/12/2005 issued by the Department of Personal and Administrative Reforms (Personnel Division), Government of Manipur.

6. Now therefore, after due consideration of the claims and objections received from the aforesaid applicants, and facts and circumstances stated above, the undersigned hereby orders that 3(three) applicants appearing in Sl. No 31, 36, and 41 of ANNEXURE-B/2 (Insufficient of Sport qualifications); 1(one) applicant appearing in Sl. No. 1 of Annexure-B/3 (Over-aged) and 12 (twelve) applicants appearing in Sl. No. 1,2,3,4,6,7,9,10,11,12,13 and 14 of ANNEXURE-C (Eligibility undecided) are inserted at ANNEXURE-A (Eligible Candidates) of this Directorate Notification of even number dated 01/06/2010.

7. With this, the claims and objections so received in this regard are hereby disposed of.


