Allocation of addl. fund amounting to **Rs.4,55,52,000/- (Rupees four crore fifty five lakh fifty two thousand)** only under Major Head: 2202-General Education, 02-Sec.Edn., 109-Govt. Sec. Schools, 24-Sec. Schools, 00,01-Salaries for meeting the expenditure for payment of monthly salaries for the month from **April 2017 to June 2017 (payable from May 2017 to July 2017)** in respect of 438 Lecturers (who were regularised vide Govt. order No.12(HC)/332/2001-SE(S) dated 12/5/2016) serving in schools in Valley District is hereby made. The DDO wise allocation of fund for payment of salaries in respect of the employees under your administrative control is detailed in the enclosed **ANNEXURE**. The present allocation is exclusive of fund for payment of arrears and back pay for which separate proposals should be submitted to the undersigned.

2. The above allocation does not *ipso facto* authorize the HOOs/DDOs to incur expenditure of the allocated amount unless all other financial rules & regulations are duly complied with.

3. Every payment of salaries shall be made against the substantive posts held by the concerned employees.


4. Both the DDOs and HOI/HOOs concerned should ensure that only the employees whose appointments are clearly established as genuine should be paid salary. In case of any employee whose service status cannot be confirmed as genuine and regular should not be made any payment and the case should be referred to the undersigned for taking up necessary measures at the earliest.

5. Any official found involved in any activity in misusing of the allotted fund will be taken action under Manipur Personal Liability Act for swindling Government fund.

6. Next allocation of fund shall be made only on receipt of relevant expenditure statements.
