3. And, 13 (thirteen) eligible applicants has now been excluded from the said 777 (seven hundred and seventy seven) on the grounds like already appointed, have Govt. convey letter for appointment, transferred to other department, etc. as detailed in the ANNEXURE-A.

4. Further, another 43 (forty-three) left out eligible applicants had also been included and placed in the appropriate places in the said list of seniority. And, 21 (twenty one) applicants to be included from the Reject-list vide this office order of even number dated the 20<sup>th</sup> July, 2017, had also been inserted in their proper places in the said list (copy enclosed).
