
Subject: - Allotment of addl fund for payment of pay and allowances for the month up to **Sept.2017**.

2. The above allocation does not *ipso facto* authorize the HOOs/DDOs incur expenditure of the allocated amount unless all other financial rules & regulations are duly complied with.
3. Every payment of salaries shall be made against the substantive posts held by the concerned employees.
4. Both the DDOs and HOI/HOOs concerned should ensure that only the employees whose appointments are clearly established as genuine should be paid salary. In case of any employee whose service status cannot be confirmed as genuine and regular should not be made any payment and the case should be referred to the undersigned for taking up necessary measures at the earliest.
5. Any official found involved in any activity in misusing of the allotted fund will be taken action under Manipur Personal liability Act for swindling Government fund.
6. Next allocation of fund shall be made only on receipt of relevant expenditure statement.
