
No. 24/1/1-2/07-DE(S)Vol-III: Whereas, Ms. BK Namriboi was appointed as Primary Teacher (SSA), on the recommendation of the Class-III DPC held on the 26th February, 2012, and posted at the Irongngoubikhong Primary School (now upgraded to Upper Primary School), Kangpokpi District vide Government Order No. 4/18/2012-SE(S) dated the 25th September, 2012. Her service was further utilized at the Gelnel High School vide Government Order No. 4/41/2012 dated 04/02/2013.

2. Whereas, the Department of Education(S), Manipur was suspicious that Ms. BK Namriboi, Primary Teacher (SSA), Irongngoubikhong Upper Primary School (under utilization at Gelnel High School) was also undergoing MSc (Agriculture) at the College of Post Graduate Studies (CAU), Umiam, Meghalaya while being employed as a Primary Teacher (SSA) at the same time.

3. Whereas, on seeking information (vide this office letter No. 24/1/1-2/07-DE(S)Vol-III/4 dated 04/10/2017) on whether the said Ms. BK Namriboi, Primary Teacher (SSA) is undergoing MSc (Agriculture) at the College of Post Graduate Studies, Umiam, Meghalaya, the Dean of the above referred College clarified, vide his office letter No. CAU/CPGS/Acad/Studies/17-18/1788 dated 17/10/2017, that Ms. BK Namriboi d/o Shri BK Isaac and Smt. Esther of Mayangkhang Ningthoupham, Kangpokpi district has been undergoing MSc (Agriculture) at the College since the 26th July, 2016.


4. Whereas, it was further clarified that MS BK Namriboi completed her BSc (Agriculture), which is of a duration of 4 years, from Tamil Nadu Agricultural University, Coimbatore, Tamil Nadu as per documents submitted by her during admission in the College of Post Graduate Studies, Umiam, Meghalaya.

5. Whereas, the said Ms. BK Namriboi was found to be already pursuing BSc (Agriculture) at the Tamil Nadu Agricultural University, Coimbatore before appointment as Primary Teacher (SSA) under the Department of Education(S), Manipur on 25/09/2012 and still undergoing MSc (Agriculture) at the College of Post Graduate Studies, Umiam, Meghalaya, the appointment of Ms. BK Namriboi is treated as null and void.



6. Now, therefore, the appointment of Ms. BK Namriboi as Primary Teacher (SSA) under the Department of Education (S), Manipur issued vide Order No. 4/18/2012-SE(S) dated 25/09/2012 is hereby cancelled.

7. It is, further, ordered that the Zonal Education Officer (Kangpokpi), Government of Manipur shall recover the pay & allowances wrongfully drawn by Ms. BK Namriboi and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
