
No. 24/1/1-2/07-DE(S)Vol-IV: Whereas, **Ms. Rubeiya Huda, daughter of Hesamuddin of Lilong Hangamthabi, PO/PS Lilong, Thoubal district** was appointed as Primary Teacher (SSA), on the recommendation of the Class-III DPC held on the 26th February, 2012, and posted at the Bengi Primary School, Thoubal district vide Government Order No. 4/18/2012-SE(S) dated the 25th September, 2012.

2. Whereas, the proposal of Ms. Rubeiya Huda for resignation from her post of Primary Teacher (SSA) was accepted vide this office Order No. 24/1/1-2/07-DE(S)Vol-III(2) dated 04/05/2017 w.e.f. 27/12/2016 (AN).

3. Whereas, the Department of Education(S), Manipur became suspicious that Ms. Rubeiya Huda, EIN: 089132, Primary Teacher (SSA) of Bengi Primary School was also undergoing MBBS Course at the Jawaharlal Nehru Institute of Medical Sciences, Porompat while being employed as a Primary Teacher (SSA) at the same time.

4. Whereas, on seeking information on whether the said Ms. Rubeiya Huda, Primary Teacher (SSA) is undergoing MBBS Course at Jawaharlal Nehru Institute of Medical Sciences, Porompat, the Dean (Academic), Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Porompat confirmed that **Ms. Rubeiya Huda has been a regular student since her admission into MBBS course in the Institute on the 25th August, 2012. She appeared all the Professional Examinations timely and passed all the examinations regularly and presently doing her One Year Compulsory Rotatory Internship w.e.f. the 1st March, 2017** vide their office letter No. JIMS/Academic.3(5)/Corresp/12/1245 dated 27/11/2017.


5. Whereas, the said Ms. Rubeiya Huda was found to be already pursuing MBBS Course at Jawaharlal Nehru Institute of Medical Sciences, Porompat (since her admission to the MBBS course on 25/08/2012) before appointment as Primary Teacher (SSA) under the Department of Education(S), Manipur on 25/09/2012, the appointment and acceptance of resignation of Ms. Rubeiya Huda are treated as ***null and void***.



6. Now, therefore, the appointment of Ms. Rubeiya Huda as Primary Teacher (SSA) under the Department of Education (S), Manipur issued vide Order No. 4/18/2012-SE(S) dated 25/09/2012 and acceptance of her resignation issued vide Order No. 24/1/1-2/07-DE(S)Vol-III(2) dated 04/05/2017 are hereby **cancelled**.

7. It is, therefore, ordered that Zonal Education Officer (Zone-III), Government of Manipur shall lodge an FIR against Ms. Rubeiya Huda, daughter of Hesamuddin of Lilong Hangathabi, PO/PS Lilong, Thoubal district for alleged fraudulence and wrongful drawal of pay and allowances etc. under appropriate clauses of IPC within a period of one month from the date of issue of this order.

8. It is, further, ordered that the Zonal Education Officer (Zone-III), Government of Manipur shall recover the pay & allowances wrongfully drawn by Ms. Rubeiya Huda and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
