
No. 24/1/1-2/07-DE(S)Vol-III: Whereas, Md. Taj Mahammad was appointed as Primary Teacher (SSA), on the recommendation of the Class-III DPC held on the 26th February, 2012, and posted at the Konthoujam Maning Tribal Primary School, Imphal West vide Government Order No. 4/18/2012-SE(S) dated the 25th September, 2012.

2. Whereas, the Department of Education(S), Manipur, during 2016, became suspicious that Md. Taj Mahammad, EIN: 087826 (transferred & posted at Konuma Primary School) was also undergoing MBBS Course at the Jawaharlal Nehru Institute of Medical Sciences, Porompat while being employed as a Primary Teacher (SSA) at the same time.

3. Whereas, on seeking information on whether the said Md. Taj Mahammad, Primary Teacher (SSA) is undergoing MBBS Course at Jawaharlal Nehru Institute of Medical Sciences, Porompat, the Dean (Academic), Jawaharlal Nehru Institute of Medical Sciences (JNIMS), Porompat submitted findings of the Inquiry Committee (of the JNIMS, Porompat) constituted for the purpose vide his office letter No. JIMS/Academic.3(5)/Corresp/12/11071 dated 03/10/2016.


4. Whereas, the said Committee constituted by Director, Jawaharlal Nehru Institute of Medical Sciences vide Memo No. JIMS/Academic.3(5)/Corresp/12-10 dated 29/09/2016 in its meeting held on 01/10/2016 at 02:00 PM under the Chairmanship of Prof. W. Gyaneshwar Singh, found that Md. Taj Mahammad was admitted to the MBBS Course on 27/08/2012 and pursuing the MBBS Course which is a full time 5½ year course (including one year internship). The said Md. Taj Mahammad is also found to be regularly attending classes.

5. Whereas, the said Md. Taj Mahammad was found to be already pursuing MBBS Course at Jawaharlal Nehru Institute of Medical Sciences, Porompat (starting from 27/08/2012) before appointment as Primary Teacher (SSA) under the Department of Education(S), Manipur on 25/09/2012, the appointment of Md. Taj Mahammad is treated as null and void.

6. Now, therefore, the appointment of Md. Taj Mahammad as Primary Teacher (SSA) under the Department of Education (S), Manipur issued vide Order No. 4/18/2012-SE(S) dated 25/09/2012 is hereby cancelled.

7. It is, further, ordered that the Zonal Education Officer (Zone-I), Government of Manipur shall recover the pay & allowances wrongfully drawn by Md. Taj Mahammad and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
