
No. 24/1/1-2/07-DE(S)Vol-IV:       Whereas, **Shri Thangjam Bibekananda Singh, son of Thangjam Rajen Singh of Ukhongshang Mayai Leikai, Thoubal district**, was appointed as Primary Teacher (SSA), on the recommendation of the Class-III DPC held on the 26<sup>th</sup> February, 2012, and posted at the Kakching Khunou New Primary School, Kakching district vide Government Order No. 4/18/2012-SE(S) dated the 25<sup>th</sup> September, 2012.

2.       Whereas, the Department of Education(S), Manipur became suspicious that **Shri Thangjam Bibekananda Singh**, Primary Teacher (SSA) of Kakching Khunou New Primary School was also undergoing MBBS Course at the Regional Institute of Medical Sciences, Imphal while being employed as a Primary Teacher (SSA) at the same time.

3.       Whereas, on seeking information on whether the said Shri Thangjam Bibekananda Singh, Primary Teacher (SSA) is undergoing MBBS Course at Regional Institute of Medical Sciences (RIMS), Imphal, the Dean (Academic) i/c, RIMS, Imphal confirmed vide their office letter No. A/197/Adm(MBBS)/2017/RIMS dated 20/12/2017 that **Shri Thangjam Bibekananda Singh is a bonafide student of Regional Institute of Medical Sciences, Imphal. He was admitted on 27/08/2012 for pursuing MBBS course in their Institution and passed his final MBBS Professional Part II examination vide Manipur University examination result No.9/9-8.2011/Exam(B) dated 19/08/2017. And, now he is doing his Internship Training Programme in RIMS, Imphal.**


4.       Whereas, the said Shri Thangjam Bibekananda Singh was found to be already pursuing MBBS Course at Regional Institute of Medical Sciences, Imphal (since his admission to the MBBS course on 27/08/2012) before appointment as Primary Teacher (SSA) under the Department of Education(S), Manipur on 25/09/2012, the appointment is treated as ***null and void***.

5.       Now, therefore, the appointment of Shri Thangjam Bibekananda Singh as Primary Teacher (SSA) under the Department of Education (S), Manipur issued vide Order No. 4/18/2012-SE(S) dated 25/09/2012 is hereby **cancelled**.



6. It is, therefore, ordered that Zonal Education Officer (Kakching), Government of Manipur shall lodge an FIR against Shri Thangjam Bibekananda Singh, son of Thangjam Rajen Singh of Ukhongshang Mayai Leikai, Thoubal district for alleged fraudulence and wrongful drawal of pay and allowances etc. under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the Zonal Education Officer (Kakching), Government of Manipur shall recover the pay & allowances wrongfully drawn by Shri Thangjam Bibekananda Singh and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
