No. 24/1/1-2/07-DE(S)Vol-IV/1:                      Whereas, **Ms. Savanai Lily RL**, daughter of **Mr. R.B. Lemo of Koide Village, Senapati district**, was appointed as Primary Teacher (SSA), on the recommendation of the Class-III DPC held on the 26<sup>th</sup> February, 2012, and posted at the Keshefii Lower Primary School, Senapati district vide Government Order No. 4/18/2012-SE(S) dated the 25<sup>th</sup> September, 2012 (later transferred to Kanjang Primary School, Senapati).

2.        Whereas, the Department of Education(S), Manipur became suspicious that **Ms. Savanai Lily RL**, Primary Teacher (SSA) of Kanjang Primary School was also undergoing MBBS Course at the Regional Institute of Medical Sciences, Imphal while being employed as a Primary Teacher (SSA) at the same time.

3.        Whereas, on seeking information on whether the said **Ms. Savanai Lily RL**, EIN: 096727, Primary Teacher (SSA) is undergoing MBBS Course at Regional Institute of Medical Sciences (RIMS), Imphal, the Deputy Director i/c, RIMS, Imphal confirmed vide their office letter No. A/197/Admn/MBBS/2017/RIMS dated 03/01/2018 that **Ms. Savanai Lily RL, daughter of Mr. R.B. Lemo of Koide Village, P.O. Maram, Senapati District, Manipur is a bonafide MBBS student of Regional Institute of Medical Sciences, Imphal. She was admitted on 10/09/2013 vide Order No. A/26/Adm(MBBS)/2013/RIMS and she is presently appearing in the final MBBS 3<sup>rd</sup> Professional Part II Examination, January, 2018.**


4.        Whereas, the said **Ms. Savanai Lily RL** was found to be pursuing MBBS Course at Regional Institute of Medical Sciences, Imphal since her admission to the MBBS course on 10/09/2013.

5.        Now, therefore, the services of **Ms. Savanai Lily RL** as Primary Teacher (SSA) under the Department of Education (S), Manipur is deemed to have been terminated w.e.f. 10/09/2013.

6. It is, therefore, ordered that Zonal Education Officer (Senapati), Government of Manipur shall lodge an FIR against **Ms. Savanai Lily RL, daughter of R.B. Lemo of Koide Village, Senapati district** for alleged fraudulence and wrongful drawal of pay and allowances etc. after getting admission to the MBBS Course at the RIMS, Imphal under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the Zonal Education Officer (Senapati), Government of Manipur shall recover the pay & allowances wrongfully drawn w.e.f. 10/09/2013 by **Ms. Savanai Lily RL** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
