
No. 24/1/1-2/07-DE(S)Vol-IV/1: Whereas, **Mohammad Mirjan Ali, son of Late Md. Raja Miah of Sonapur, Jiribam district** was appointed as an Arts Graduate Teacher (RMSA) and posted at T. Hundung High School, Ukhrul vide Government Order No. 31/4/2014-SE(S) dated the 27th September, 2014 subject to satisfactory verification of documents, antecedent and physical fitness.

2. Whereas, essential qualification for appointment to the post of Arts Graduate Teacher (RMSA), against which **Mohammad Mirjan Ali** was appointed, was (i) Graduate in Arts from recognized University/ Institute, and (ii) BEd or its equivalent from recognized University/ Institute issued, vide Notification No. 1-32/SPD/RMSA/SIS/2011 dated the 18th December, 2011, by the RMSA, SIS, Manipur.

3. Whereas, the said **Mohammad Mirjan Ali** enclosed certificate and mark sheet of BEd Examination, 2006 claiming that he studied and passed the course from the DM College of Teacher Education, Imphal while submitting Application Form for recruitment to the post of Arts Graduate Teacher (RMSA).


4. Whereas, on seeking clarification from the Principal, DM College of Teacher Education, Imphal as to whether the said **Mohammad Mirjan Ali** passed the BEd Examination, 2006, the Principal, DM College of Teacher Education, Imphal, vide letter No. 301/1/09-TE dated the 22nd February, 2018, clarified that **Mohammad Mirjan Ali** was not a student of the DM College of Teacher Education as per records maintained in the College.

5. Now, therefore, on confirming that **Mohammad Mirjan Ali** did not qualify for appointment to the post of Arts Graduate Teacher (RMSA) having not possessed BEd degree, his appointment, issued vide Order No. 31/4/2014-SE(S) dated the 27th September, 2014 to the post of Arts Graduate Teacher (RMSA), is hereby **cancelled**.



6. It is, therefore, ordered that Zonal Education Officer (Ukhrul), Government of Manipur shall lodge an FIR against **Mohammad Mirjan Ali, son of Late Md. Raja Miah of Sonapur, Jiribam district** for wrongfully entering Government service through forgery under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the Zonal Education Officer (Ukhrul), Government of Manipur shall recover the pay & allowances wrongfully drawn by **Mohammad Mirjan Ali** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
