
No. 24/1/1-2/07-DE(S)Vol-IV/2:                      Whereas, **Shri Kaphunsinpou Malangmei, son of Kamuna Malangmei of Gaipuinam, Khuman Lampak, Imphal West district** was appointed as an Arts Graduate Teacher (RMSA) and posted at Tharon High School, Tamenglong district vide Government Order No. 31/4/2014-SE(S) dated the 27<sup>th</sup> September, 2014 subject to satisfactory verification of documents, antecedent and physical fitness.

2.        Whereas, essential qualification for appointment to the post of Arts Graduate Teacher (RMSA), against which **Shri Kaphunsinpou Malangmei** was appointed, was (i) Graduate in Arts from recognized University/ Institute, and (ii) BEd or its equivalent from recognized University/ Institute issued, vide Notification No. 1-32/SPD/RMSA/SIS/2011 dated the 18<sup>th</sup> December, 2011, by the RMSA, SIS, Manipur.

3.        Whereas, the said **Shri Kaphunsinpou Malangmei** enclosed certificate and mark sheet of BEd Examination, 2004 claiming that he studied and passed the course from the DM College of Teacher Education, Imphal while submitting Application Form for recruitment to the post of Arts Graduate Teacher (RMSA).


4.        Whereas, on seeking clarification from the Principal, DM College of Teacher Education, Imphal as to whether the said **Shri Kaphunsinpou Malangmei** passed the BEd Examination, 2004, the Principal, DM College of Teacher Education, Imphal, vide letter No. 301/1/09-TE dated the 22<sup>nd</sup> February, 2018, clarified that **Shri Kaphunsinpou Malangmei** was not a student of the DM College of Teacher Education as per records maintained in the College.

5.        Now, therefore, on confirming that **Shri Kaphunsinpou Malangmei** did not qualify for appointment to the post of Arts Graduate Teacher (RMSA) having not possessed BEd degree, his appointment, issued vide Order No. 31/4/2014-SE(S) dated the 27<sup>th</sup> September, 2014 to the post of Arts Graduate Teacher (RMSA), is hereby **cancelled**.



6. It is, therefore, ordered that Zonal Education Officer (Tamenglong), Government of Manipur shall lodge an FIR against **Shri Kaphunsinpou Malangmei, son of Kamuna Malangmei of Gaipuinam, Khuman Lampak, Imphal West district** for wrongfully entering Government service through forgery under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the Zonal Education Officer (Tamenglong), Government of Manipur shall recover the pay & allowances wrongfully drawn by **Shri Kaphunsinpou Malangmei** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
