
No. 24/1/1-2/07-DE(S)Vol-IV/3:                      Whereas, **Smt. Thokchom Subashini Devi, wife of Lourembam Ibopishak Singh of Thoubal Wangmataba, P.O. & P.S. Thoubal** was appointed as a Science Graduate Teacher (RMSA) and posted at Tollen High School, Tengnoupal district vide Government Order No. 31/4/2014-SE(S) dated the 27<sup>th</sup> September, 2014 subject to satisfactory verification of documents, antecedent and physical fitness.

2.        Whereas, essential qualification for appointment to the post of Science Graduate Teacher (RMSA), against which **Smt. Thokchom Subashini Devi** was appointed, was (i) Graduate in Science from recognized University/ Institute, and (ii) BEd or its equivalent from recognized University/ Institute issued, vide Notification No. 1-32/SPD/RMSA/SIS/2011 dated the 18<sup>th</sup> December, 2011, by the RMSA, SIS, Manipur.

3.        Whereas, the said **Smt. Thokchom Subashini Devi** enclosed certificate and mark sheet of BEd Examination, 2008 claiming that she studied and passed the course from the DM College of Teacher Education, Imphal while submitting Application Form for recruitment to the post of Science Graduate Teacher (RMSA).


4.        Whereas, on seeking clarification from the Principal, DM College of Teacher Education, Imphal as to whether the said **Smt. Thokchom Subashini Devi** passed the BEd Examination, 2008, the Principal, DM College of Teacher Education, Imphal, vide letter No. 301/1/09-TE dated the 22<sup>nd</sup> February, 2018, clarified that **Smt. Thokchom Subashini Devi** was not a student of the DM College of Teacher Education as per records maintained in the College.

5.        Now, therefore, on confirming that **Smt. Thokchom Subashini Devi** did not qualify for appointment to the post of Science Graduate Teacher (RMSA) having not possessed BEd degree, his appointment, issued vide Order No. 31/4/2014-SE(S) dated the 27<sup>th</sup> September, 2014 to the post of Science Graduate Teacher (RMSA), is hereby **cancelled**.



6. It is, therefore, ordered that Zonal Education Officer (Tengnoupal), Government of Manipur shall lodge an FIR against **Smt. Thokchom Subashini Devi, wife of Lourebam Ibopishak Singh of Thoubal Wangmataba, P.O. & P.S. Thoubal** for wrongfully entering Government service through forgery under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the Zonal Education Officer (Tengnoupal), Government of Manipur shall recover the pay & allowances wrongfully drawn by **Smt. Thokchom Subashini Devi** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
