No. 24/1/1-2/07-DE(S)Vol-IV/4: Whereas, **Shri Tourangbam Kenedy Singh, son of Shri Tourangbam Mukesh Singh of Thoubal Achouba Bazar Maya, Thoubal district**, was appointed as a Primary Teacher (SSA) and posted at Thawai Primary School, Ukhrul district vide Government Order No. 4/38/2012-SE(S) dated the 18th November, 2013 subject to satisfactory verification of documents, antecedents and physical fitness.


2. Whereas, the Department of Education(S), Manipur became suspicious that **Shri Tourangbam Kenedy Singh**, Primary Teacher (SSA) of Thawai Primary School is also serving as District Computer Operator at District Headquarter Thoubal under State Health Society, NHM, Manipur while being employed as a Primary Teacher (SSA) at the same time.

3. Whereas, on seeking information on whether the said **Shri Tourangbam Kenedy Singh**, EIN: 096906, Primary Teacher (SSA) is serving as District Computer Operator at District Headquarter Thoubal under State Health Society, NHM, Manipur, the State Mission Director, State Health Society, NHM, Manipur confirmed vide their office letter No. 468/01/NHM-2017(HR) dated 11/01/2018 that **Shri Tourangbam Kenedy Singh, son of Shri Tourangbam Mukesh Singh of Thoubal Achouba Bazar Maya, Thoubal district was appointed as District Computer Operator, District Headquarter Thoubal vide Memorandum No. 7/NRHM/TBL-06/ dated the 6th January, 2010.**


4. Whereas, the said **Shri Tourangbam Kenedy Singh** is found to be already serving as District Computer Operator at District Headquarter Thoubal under State Health Society, NHM, Manipur since 06/01/2010 (i.e., before his appointment as Primary Teacher (SSA) on 18/11/2013), the appointment is treated as ***null and void***.

5. Now, therefore, the appointment of **Shri Tourangbam Kenedy Singh** as Primary Teacher (SSA) under the Department of Education (S), Manipur issued vide Order No. 4/38/2012-SE(S) dated the 18th November, 2013 is hereby **cancelled**.

6. It is, therefore, ordered that Zonal Education Officer (Ukhrul), Government of Manipur shall lodge an FIR against **Shri Tourangbam Kenedy Singh, son of Shri Tourangbam Mukesh Singh of Thoubal Achouba Bazar Maya, Thoubal district** for alleged fraudulence and wrongful drawal of pay and allowances etc. under appropriate clauses of IPC within a period of one month from the date of issue of this order.



7. It is, further, ordered that the Zonal Education Officer (Ukhrul), Government of Manipur shall recover the pay & allowances wrongfully drawn by **Shri Tourangbam Kenedy Singh** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
