ORDERS BY THE GOVERNOR: MANIPUR
Imphal, the 28th February, 2018

No.12(HC)/332/2001-SE(S)(Pt.-3): WHEREAS, a total of 707 (seven hundred and seven) Contract Lecturers serving in Government Higher Secondary Schools were regularized, vide this Government Order No. 12(HC)/322/2001-SE(S), dated 12/5/2016 subject to verification of character, antecedents, medical fitness, testimonial as well as their continuous service as Contract Lecturers in the Education-S Department.

2. WHEREAS, as per the verification report of the Director/Education-S vide letter no. AO/253/RCL/2016(6)-DE(S) dated 23/09/2016, the 4 (four) Contract Lecturers whose services were to be regularized namely, (i) A.S. Gracehome (ii) Papouchunlung Moimai (iii) M.S. Renglenrang and (iv) P. Biget Singh have scored less than 50% marks in their Post Graduate Degree.


3. WHEREAS, as per the existing R/R for the post of Lecturer notified, vide DP's Notification No. 1/32/86-(RR)/DP, dated 28/08/1997, a person should be a Post Graduate degree holder with at least 50% marks in the concerned subject in Post-Graduation from a recognized University.

4. WHEREAS, the aforementioned these 4 (four) Lecturers were left out during the time of regularization of other Contract Lecturers in the list of aforementioned 707 lecturers as they did not meet the requisite eligibility criteria to be a Lecturer in Education-S department.

5. AND WHEREAS, the Education-S Department has referred the matter to the Department of Personnel which has advised "to initiate immediate action for cancellation of regularization order of the 4 (four) teachers who were found non eligible as per Recruitment Rules and recover all allowances paid so far, if any".

7. Now, therefore, after due consideration, the Governor of Manipur is pleased to cancel the regularization of the 4 (four) teachers viz, (i) A.S. Gracehome (ii) Papouchunlung Moimai (iii) M.S. Renglenrang and (iv) P. Biget Singh with immediate effect on the ground that they have not fulfilled the requisite qualifications as prescribed in the applicable Recruitment Rules for Lecturers in Education-S Department.
