NOTIFICATION
Imphal, the 23rd January, 1996.

No. 1/30/95-RR/DR. In supersession of all previous rules issued in this regard and in exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Manipur hereby makes the following rules, namely:-

1. SHORT TITLE AND COMMENCEMENT:- (1) These rules may be called the Department of Education, Manipur (Class. Principals, Hr. Sec. Schools) Recruitment Rules, 1995.
(2) They shall come into force with effect from the date of publication in the Manipur Gazette.
2. APPLICATION:- These rules shall apply to the posts specified in column 1 of the MPSC Form-B annexed hereto.
3. CLASSIFICATION, SCALE OF PAY, METHOD OF RECRUITMENT etc.:- Classification of the said posts, scale of pay, method of recruitment and other matters connected therewith shall be as specified in columns 3 to 13 of the said MPSC Form-B.
4. DISQUALIFICATION:- No person
(a) who has entered into or contracted a marriage with a person having a spouse living, or
(b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the aforesaid post.
Provided that the Governor may be satisfied that such marriage is permissible under the Personal Law applicable to each person and the other party to the marriage and that there are no grounds for excluding any person from the operation of these rules.
5. POWER TO RELAX:- Where the Governor is of opinion that it is necessary or expedient to do so, he may order for reasons to be recorded in writing, and in consultation with the Manipur Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.
