
In inviting a reference to Government letter No.5(4)/1/2017-SE(S)DIH dated 20-01-2018 and DP OM No.20/38/2017-DIH/DP dated 07-12-2017 & DP OM No. 20/15/20002/-DIH/DP dated 20-02-2018 on the above subject I am to state that a total number of applications received in the Directorate are **1210 (one thousand two hundred ten)** only as on 31-12-2017 for appointment under die-in-harness scheme in the Department of Education(S), Manipur.

2. The **1210 applications** are categorised into three groups [based on date of submission/relevant documents submitted] for appointment under the said scheme i.e. (i) eligible and complete documents as per DP OMs, (ii) eligible and incomplete documents and (iii) applicants to be removed/deleted due to double claimed/transferred to other departments/appointed as Govt. job/expired of the applicants, etc. as per decision of the meeting held on 30-04-2018.


