
No. 24/1/1-2/07-DE(S)Vol-IV/1: Whereas, **P. Rebecca Rangnamei, daughter of S. Paoshiba of Katomei village, Senapati district** was appointed as a Science Graduate Teacher (RMSA) on the recommendation of the Class-III DPC held on 18/11/2016 to 22/11/2016 and 08/12/2016 vide Order No. AO/144/RMSA/2016(5)-DE(S) dated the 22nd December, 2016 strictly subject to verification of character, antecedents, medical fitness and educational certificates & testimonials etc. and posted at Yangkhullen High School, Senapati district vide Order No. AO/144/RMSA/2016(5)-DE(S) dated 16/01/2018. Later, she was transferred and posted at Molphei Tampak High School vide Orders No. AO/59/TT/(RMSA/SSA)/2011(4)-DE(S) dated 23/06/2018.

2. Whereas, essential qualification for appointment to the post of Science Graduate Teacher (RMSA), issued vide Notification No. AO/144/RMSA/2016(5)-DE(S) dated 11/05/2016, was (i) Graduate in Science from recognized University/ Institute, and (ii) BEd or its equivalent from recognized University/ Institute.

3. Whereas, the said **P. Rebecca Rangnamei** enclosed certificate and mark sheet of BEd Examination, 2013 while submitting Application Form for recruitment to the post of Science Graduate Teacher (RMSA), the originals of which were also produced on the day of her viva voce for recruitment to the post applied.

4. Whereas, on seeking clarification from the Principal, Trinity Teacher Training College, Koirengai as to whether the said **P. Rebecca Rangnamei** passed the BEd Examination, 2013, the Principal, Trinity Teacher Training College, Koirengai, vide letter No. T.T.T.C./21/12-ED/Corspdt dated the 3rd July, 2018, clarified that **P. Rebecca Rangnamei** was not a student of the Trinity Teacher Training College, Koirengai and that she had not appeared/ passed the BEd Examination, 2013 as per records maintained in the College.


5. Now, therefore, on confirming that **P. Rebecca Rangnamei** did not qualify for appointment to the post of Science Graduate Teacher (RMSA) having not possessed BEd degree, her appointment to the post of Science Graduate Teacher (RMSA), issued vide Order No. AO/144/RMSA/2016(5)-DE(S) dated the 22nd December, 2016 & subsequent posting Order No. AO/144/RMSA/2016(5)-DE(S) dated the 16th January, 2018 and transfer & posting Orders No. AO/59/TT/(RMSA/SSA)/2011(4)-DE(S) dated 23/06/2018, are hereby **cancelled**.

6. It is, therefore, ordered that the Zonal Education Officer, Churachandpur shall lodge an FIR against **P. Rebecca Rangnamei, daughter of Shri S. Paoshiba of Katomei village, Senapati district** (under transfer & posting at Molphei Tampak High School, Churachandpur) for wrongfully entering Government service through forgery under appropriate clauses of IPC within a period of one month from the date of issue of this order.

7. It is, further, ordered that the State Project Director, RMSA, SIS, Manipur shall recover the pay & allowances wrongfully drawn by **P. Rebecca Rangnamei** and be deposited in the relevant head of accounts within a period of 6 (six) months from the date of issue of this order.
