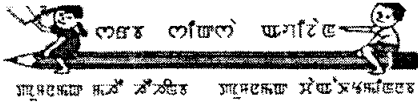
Whereas, it is reportedly learnt that construction of Upper Primary School sanctioned to the above mentioned school approved in 2012-13 has not started/completed as on date.

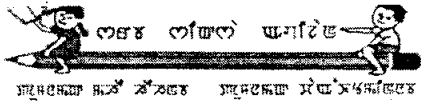
