ORDERS

Imphal, the 9 October, 2018.

No. 46/3/2018-ED(S/V): Whereas Shri Kh.Ibochou Singh, Primary Teacher of Tangjeng Ahallup Primary School (under utilisation at Ithai Khunou High School) was placed under suspension in contemplation of a disciplinary proceeding against him under this office order No. 24/1/1-2/07-DE(S) Vol-I (3) dated the 4th April, 2016.


2. And, whereas Kh. Ibema Devi w/o the said Shri Kh.Ibochou Singh has submitted a representation dated the 3rd August, 2018 requesting therein to consider for revocation of the order placing the Shri Kh.Ibochou Singh under suspension.

3. And, whereas the Government has instructed to examine the feasibility for revocation of the suspension order of the said Shri Kh.Ibochou Singh vide Government letter No. 29/51/2015-SE(S) Misc. dated the 30th August, 2018.

4. And, whereas the matter attending suspension of the said Shri Kh.Ibochou Singh has been examined and considered that suspension of the said teacher was found to have been made for not joining his duty at Ithai Khunou High School, where his service was utilised. And, necessary follow-up action consequent upon suspension of the said teacher is found to have not been taken up.

5. Now, therefore, in consideration of the above facts and circumstances and in pursuance of the Government letter dated the 30th August, 2018 as referred above and the above facts and circumstances, the undersigned in exercise of the powers conferred by Clause (C) of sub-rule (5) of the Rule 10 of the Central Civil Services (Classification, Control and Appeal) Rules, 1965 hereby revokes the said order dated the 4th April, 2016 placing the said Kh.Ibochou Singh under suspension with immediate effect.

6. The pay and allowances for the period during which the said Kh.Ibochou Singh was placed under suspension, shall be paid after proper verification and adjustment of subsistence allowance if ever paid.
