
No. AO/56/ACB/2010 (3)-DE(S)Pt-I: Whereas the Petitioners in W.P (C) No. 1019 of 2018, W.P.(C) No.1026 of 2018 and W.P (C) No. 1030 of 2018 had been allowed to sit/ appear for/in the Written Test to be held on the 11th November, 2018 for recruitment of Lecturers of Hr. Sec. Schools on contract basis under this Department by issuing provisional Admit Cards during office hours with effect from the 6th to 8th November, 2018 under this office order of even number dated the 3rd November, 2018 and 5th November, 2018 in compliance with the interim orders dated the 30th October, 2018 and 5th November, 2018 of the Hon'ble High Court of Manipur passed in aforementioned writ petitions.

2. And, whereas it is of the considered view that non-consideration of other candidates, who are similarly situated with the aforesaid petitioners may arise /attract the question of violating natural justice. As such, it is felt appropriate and fair to consider similar candidates in order to end justice.

3. Now, therefore, after due consideration of the facts and circumstances stated above, it has been arrived at the decision as ordered herein that the eligible candidates in possession of Master Degree in Public Administration for **Political Science Subject**, Analytical Chemistry for **Chemistry Subject**, Biochemistry, Biotechnology, Microbiology, Molecular biology and Biotechnology for **Botany Subject**, Biochemistry, Animal Biotechnology, Biotechnology, Bio Science for **Zoology Subject** are allowed to sit/ appear for/in the Written Test to be held on the 11th November, 2018 for recruitment of Lecturers of Hr.Sec.Schools on contract basis.

4. The Candidates concerned are therefore, informed to collect their Provisional Admit Cards from the Conference Hall of this Directorate during office hours w.e.f. 6th to 8th November, 2018 on production of the receipt slip issued at the time of form submission in this regard,

5. Recruitment/ Appointment of the candidates concerned shall be subject to the outcome of the aforesaid writ petitions.
