**PROCEDURES/ GUIDELINES FOR ADMISSION TO 12 SELECT  
GOVT. HR. SEC. SCHOOLS COVERED UNDER JOINT ADMISSION  
SYSTEM AS PER CET, 2019 MARK SCORE**

1. Admission to these 12(twelve) Schools shall be made on the basis of the marks obtained in the Common Entrance Test (CET), 2019 depending on the number of seats available and as per the cut-off mark set by the respective school(s). Reservation of seats shall be as per relevant reservation rules for admission.
2. Candidates whose CET mark is within the cut-off mark range set by the school(s) have to apply for availing admission by filling in the prescribed format issued by the respective schools by mandatorily mentioning the CET roll numbers.
3. The last date for issue of Forms, admission details and documents to be submitted shall be notified by the respective schools. Claims for admission beyond the stipulated time shall not be entertained even if found qualified once the seats are exhausted.
4. Candidates who are appearing for the Compartmental Examination, 2019 and who are found eligible for admission as per the cut-off mark set by the School should submit an Application addressed to the respective Principal for reserving their seats. Admission will be subject to their passing the Compartmental Examination: Those who fail to submit the Application timely will not be entertained in future.
5. In cases where seats are not filled up within the stipulated time frame, a new cut-off mark shall be set by the schools and the above procedure shall be followed till all the seats are exhausted/filled.
6. A list of admitted candidates shall be displayed on the School Notice Board.
