No.54/2/2013-SE(S)Pt : In supersession of all previous orders/OMs issued in this regard, the Governor of Manipur is pleased to re-constitute a TECHNICAL COMMITTEE comprising of the following officers for grant of Senior Scale/ Selection Grade Scale/ Trained Scale/ Trained Senior Scale/ Trained Selection Grade Scale/ Untrained Selection Grade Scale to the Teachers, Lecturers and other categories of employees of Education (S) Department without further reference to the Finance Department (PIC), Government of Manipur :

2. The Committee shall have the following Terms of reference.


- (a) Whether the teachers who were initially appointed on adhoc /substitute / officiating capacity had been regularized as per Office Memoranda issued by the Department of Personnel from time to time or not. If not, whether concurrence of Department of Personnel in each case had been obtained or not ?
- (b) Whether approval of the competent authority was obtained for prosecution of higher studies in respect of those teachers who have been promoted / upgraded as per higher educational qualifications.
- (c) Whether the so-called "qualification scales" were granted to the teachers on possessing higher educational qualification(s).
- (d) Whether under-matriculate/ matriculate teachers were granted the pay scale of under-graduate/ graduate.
- (e) Whether concurrence of Department of Personnel was obtained in cases of appointment under die-in-harness scheme.
- (f) Verification of Service Books to confirm if events in the service career of the teachers, such as, passing of B.Ed./ higher qualification(s), grant of senior scale, study leave are duly recorded therein.
- (g) Whether clarification(s) sought for by the Office of the Accountant General (A&E) regarding grant of senior scale after 2(two) years under ROP, 1990 [after merging from 3(three) tier to 2(two) tier] in respect of Lecturers of Higher Secondary Schools was / were clarified and, if so, whether senior scale after 12 years shall still be granted to them.

- (h) The committee shall have at least 2 (two) sitting every year. However, the number of sitting may be increased as per requirement and
- (i) The committee shall submit the recommendation to the Government for approval.
