



OFFICE MEMORANDUM

Imphal, the 31st July, 2019

Subject: Merging of Group 'D' posts in the Pay Level - 1 (pre-revised Grade Pay of Rs. 1650)

No. 1/10/2018-FD(PIC): As per the recommendations of the Fitment Committee on implementation of 7th CPC recommendations in the State, and subsequent Cabinet decision taken in its meeting held on 27.06.2019, the undersigned is directed to state that Group D posts in the Pay Level-A (pre-revised Grade Pay of Rs. 1300) and Level-B (pre-revised Grade Pay of Rs. 1400) under the MS(RP) Rules 2019 shall be merged in the Pay Level-1 (pre-revised Grade Pay of Rs. 1650) in the following manner :-

1. All existing incumbents of Group 'D' posts in the Level-A (pre-revised Grade-Pay of Rs. 1300) and Level-B (pre-revised Grade pay of Rs. 1400) possessing matriculate qualification shall be upgraded to Level-1 (pre-revised Grade Pay of Rs. 1650) along with the post, with effect from 01.07.2019.
2. The existing non-matriculate Group 'D' employees will be retained in their respective Levels. The posts shall be automatically upgraded to Level-1 as and when vacated by the incumbents upon retirement/ expiry/ promotion.
3. Further, an opportunity would be given to the non-matriculate Group 'D' employees retained in the Level-A and B to acquire matriculation and upon which, they will also be upgraded to Level-1 along with the post from the date of acquiring such Matriculate Certificate i.e. upgradation will be prospective only.
4. The status of existing Group 'D' employees currently drawing pay in the Level-1 (pre-revised Grade Pay of Rs. 1650) will remain unchanged irrespective of matriculate/ non-matriculate.
5. All future recruitments or appointments to Group 'D' posts shall be in the Level-1 (pre-revised Grade Pay of Rs. 1650) with minimum qualification of Matriculate.
6. Group 'D' posts in the Pay Level-A and B shall become dying cadres.
7. No employees shall be downgraded with the coming into effect of above changes.
