NO.2/4-10/2018-ED (V) : Whereas the Secretariat Education Department vide Order No.2/1/2019 -SE (S) dated 12-06-2019 has ordered for Amalgamation of several schools to nearby schools having better infrastructure, connectivity, students' enrolment, possibilities of growth & overall improvement in schools & Education sector; [Annexure -A]

2. and , whereas the Department has received several representation(s) from certain quarters showing objection to the Government exercise for amalgamation of schools;

3. and, whereas, based on the representations received & complaints reported in the press media, a list of such objections were compiled .Out of all such complaints received, some such cases were found genuine for consideration for new amalgamation, some for review and some for correction of nomenclature etc ; [Annexure-B]

4. and, whereas the Department received several other representations from various quarters for reconsideration from the amalgamation process. Amalgamation exercise for such cases may be kept in abeyance for the time as this requires a decision at the higher level. A list of such schools is at **Annexure-C**.

5. Now therefore, in consideration of the developments as aforementioned at para 4 above, its hereby notified for information to all the Zonal Education Officers, Heads of High Schools/ Jr.High Schools / Primary Schools that amalgamation of such amalgamated schools excepting those mentioned at para No.4 put into effect with immediate effect from the present academic session 2020-2021 without fail.

6. The assets of these amalgamated schools viz land, buildings, grounds etc. may be used in a more resourceful manner by converting it into Teacher Transit camps, Resource Centre(s), Office(s), Libraries, Playfields, Anganwadi Centre/ Kids Day Care Centre etc. depending on the situation for which a separate Order will be issued.
