No.29/53/2019-SE(S)Misc(Pt.1): In supersession of this Government Order No.29/53/2019-SE(S)Misc dated 29th July, 2019, the Governor of Manipur is pleased to re-constitute the "School Fagathansi Mission Management Committee (SFMMC)" for each of the Schools covered under the School Fagathansi Mission with the following composition as below:

- I. (i) Hon'ble Member of Legislative Assembly
(of the concerned Assembly Constituency) - Chairperson
(ii) Deputy Commissioner (of the District) - Vice Chairperson
(iii) Zonal Education Officer (of the Zone) - Member
(iv) 2(two) Parent representatives (1 from among ladies) - Member(s)
(v) Principal/Headmaster of the School (Vice-Principal/
Asst. Headmaster in absence of Principal/Headmaster) - Convenor

The Vice- Chairperson will chair the deliberation of the said Committee in the absence of the Chairperson.

II. Terms & Conditions:

1. The validity of the "SFMMC" will be for a period of 2(two) years from the date of constitution of the Committee
2. To entrust civil/construction/development related works and its monitoring and supervision to the proposed "School Fagathansi Mission Management Committee" of the Schools subject to approval of the Department on the recommendation of the SFMMC.
3. To open a dedicated Bank Account in a Nationalized Bank for the said Committee in the name "SFMMC- (Name of School)", which is to be operated by the Convenor of the Committee and to be duly countersigned by the ZEO concerned.
4. To allow the Department of Education (S), Manipur to designate a "Technical Supervision Agency" for civil/construction related works from among Engineering Department/Agencies/Cells under the State Government to oversee technical aspect of the works undertaken in these Schools.

This is issued in pursuance of Cabinet Decision taken on 03/08/2019 and with the concurrence of the Finance Department vide their U.O. No.101/2019-2020/FD(PIC), dated 22-08-2019.
