Whereas the erstwhile Gokul High School (Aided), Nachou Potsangbam, Bishnupur District was converted into full-fledged Government High School and amalgamated with Gokul Junior High School (Govt.) under the new nomenclature as Gokul High School by way of absorbing the services of the 3 (three) Approved Graduate Teachers as detailed hereinafter vide Government Order No. 46/49/2016-SE(S) dated the 23rd November, 2016.

- And, whereas in pursuance of the approval of the Government vide letter No. 2. 46/49/2016-SE(S) dated the 29th October, 2019, a meeting of the State Level Screening Committee was held on the 7th March, 2020 for appointment of the said 3 (three) Approved Teachers as regular Graduate Teachers. And, the approval of the Government to the proceedings of the said Committee submitted to the Government under this office letter No. 4/61/2009-ED(AD/H) dated the 13th March, 2020, has been conveyed under Govt. letter No. 46/49/2016-SE(S) dated the 4th May, 2020.
- Now, therefore, on the recommendation of the State Level Screening 3. Committee meeting held on the 7th March, 2020 and pursuant to the approval of the Government to this effect vide letter No. 46/49/2016-SE(S) dated the 4th May, 2020, the said Approved Graduate Teachers as detailed hereinafter shall be deemed to have been appointed as regular Graduate Teachers in Gokul High School w.e.f. 23rd **November, 2016** in the scale of pay of Rs. 9,300-34,800 + AGP: Rs 3,900 against the posts created as shown against their names
