No. AO/256/Reg.SSA/RMSA/2016(12)-DE(S)Pt: Whereas, the Secretariat, Education (S) Department, Manipur vide its Order No. 30/39/2016-SE(S) dated 08/03/2019 has regularised 91(Ninety-one) Special Teachers including (I)Kshetrimayum Purnachandra Singh, Sl. No. 9, Annexure-I, (II) Hanjabam Kunjabati Devi, Sl No. 11, Annexure-I, (III) Sijagurumayum Premananda Sharma, Sl. No. 27, Annexure-I and (IV) Oinam Radhapyari Devi, Sl. No. 61, Annexure-I subject to the verification of character, antecedents, medical fitness, testimonials, etc.

2. Whereas, Verification Committee, after verification of the parameters was of the opinion that the services of the 4(Four) incumbents as noted at Para 1 above who were found to be overaged at the time of initial contractual engagement may be regularised only after taking approval of the competent authority (i.e. Cabinet).

A copy of Proceedings of the Verification Committee meeting held on 18/11/2019 in this regard was also sent to the Government vide DE(S) Letter No. AO/256/Reg.SSA/RMSA/2016(12)-DE(S)Pt, dated 18/11/2019.

3. Whereas, the Directorate of Education (S) Manipur, vide its Order No. 24/1/1-2/07-DE(S)Vol-II(1)5, dated 03/01/2017 had also regularised 46(Fortysix) Special Graduate Teachers including one **S. Sachirani Devi** at Sl. No. 46 of the Annexure Subject to the verification of character, antecedents, medical fitness, testimonials, etc.

4. Whereas, the Verification Committee, after checking all the related documents, was of the opinion that the regularization of the services of one incumbent as mentioned at Para No. 3 above who was found to be overaged at the time of contract appointment shall be subject to the clearance by the State Cabinet.

A copy of resolutions adopted during Verification Committee meeting held on 25/07/2018 was also sent to the Government vide DE(S) Letter No. AO/256/Reg.SSA/RMSA/2016(12)-DE(S)Pt dated 11/09/2018 for their reference.

5. Whereas, the Secretariat, Education (S) Department, Manipur vide its Order No. 30/33/2016-SE(S) dated 16/12/2016 had also regularised 64(Sixty-four) Resource Persons (RTE) including one **Nonibala Khumanthem** at Sl. No. 45 of the Annexure subject to the verification of character, antecedents, medical fitness, testimonials, etc.

6. Whereas, the Verification Committee Meeting held on 22<sup>nd</sup> and 23<sup>rd</sup> June, 2018 resolved that the regularization of the Resource Person as mentioned at Para 5 above who was found overaged at the time of contractual appointment shall be subject to subsequent findings.

Whereas, the Secretariat, Education (S) Department, Manipur vide its letter No. 30/14/2016-SE(S) dated 20/06/2020 conveyed approval of the State Government to the relaxation of upper age and under age limits of 9 (Nine) employees of the Department of Education (S) including that of 6 (Six) employees as mentioned in para 1, 3 and 5 above. Also stated that the approval was made in a Cabinet meeting held on 05/06/2020.

8. Now, therefore, the Director of Education (S), Manipur is pleased, in supersession of all the previous Orders in this regard, to regularize the services of the following 6(Six) employees to the post, Scale of Pay, Sanctioned Order No., Finance Concurrence No., Date of Effect, etc. as shown against their names.
