

2. The allocation is made in exercise of the powers delegated under Item No. 7 of Schedule-III (Education Department) of the Delegation of Financial Powers Rules 1995 as amended vide Notification No. 1/2/2001-FX(EXP) dated 12-05-2014 of the Secretariat Finance Department (Expenditure Section), Manipur.
3. Future allocation of fund for payment of salary to approved teachers of Grant-in-aid schools shall be subject to issue of list of employees and sanctioned strength of these schools certified by the Directorate of MIS, Finance Department, Manipur.
4. It is further to add that the release/sanction of Grant-in-aid to the Aided schools shall be subject to fulfillment of all eligibility criteria and terms and conditions laid down in relevant rules for claiming the grant.
5. The concerned DDOs should maintain absolute financial propriety and ensure that no excess payments are made in any manner as warranted under relevant rules.
6. The above allocation does not ipso facto authorise the DDO's to incur expenditure unless all other financial rules and regulations are fulfilled.
7. This allocation of fund is made further subject to the condition that the ZEOs should ensure that the necessary sanctions are accorded only for the employees whose requirement of S.I.N. is fulfilled.
