
NOTIFICATION

No. AO/13/CA/2009(6)-DE(S)Pt-III: In pursuance of the Government letter No. 5(4)/1/2017-SE(S)DIH/Pt-III dated 14-07-2019 and in continuation of this Notification of even number dated 16-08-2018, it is hereby informed that the applicants who are eligible for appointment to the post of Primary Teacher/Hindi Primary Teacher under the die-in-harness scheme in the Department of Education(S), Manipur (as per NCTE norms vide NCTE Notification No.61-03/20/2010/NCTE/(N&S) dated 23-08-2010 and No. NCTE-Regl 012/16/2018 dated 28-06-2018) should submit their particulars in the prescribe PROFORMA (enclosed as **Annexure-I**) along with supportive documents (i.e. relevant certificates and mark-sheets, etc.) to this Directorate on or before **10th November, 2020** so as to enable to take necessary action in timely. The eligible criteria for the post of Primary Teachers/Hindi Primary Teachers are also shown in the enclosed **Annexure-II**.

Further, those applicants who had applied for the post of Primary Teacher/Hindi Primary Teacher under die-in-harness scheme should also submit their particulars in the prescribe PROFORMA (enclosed as **Annexure-I**) along with supportive documents (i.e. relevant certificates and mark-sheets, etc.) as per NCTE norms failing which their appointment will be considered to any other appropriate post commensurate with their educational qualifications.

Moreover, those applicants who are not eligible for appointment to the post of Primary Teacher/Hindi Primary Teacher as per NCTE norms although they had applied for the post of Primary Teacher/Hindi Primary Teacher should submit no objection to their appointment to any post commensurate with their educational qualification in the FORMAT (enclosed as **Annexure-III**) failing which further claims shall not be entertained.
