No: AO/233/AGT/2014(9)-DE(S): Whereas, vide notification of even number dated 18<sup>th</sup> March, 2021 list of rejected and pending candidates were notified and invited to submit claims & objections, if any, upto 25<sup>th</sup> March, 2021.

- 2. Whereas, a Class-III DPC for the selection/engagement of 923(nine hundred and twenty three) Graduate Teachers on contract basis was constituted vide Govt. Order No. 33/14/2019-SE(S)/Pt, dt. 5th August, 2021. Accordingly, this Committee examined the lists of verified, pending & rejected candidates and claims and objection received in this regard were considered and made the following recommendations.
  - a. The list of candidates as given in **Annexure-I** were approved from among the pending candidates and hence declared eligible for appearing in the examination.
  - b. The list of candidates as given in **Annexure-II** were rejected from the pending candidates on various grounds given against their name and hence declared ineligible for appearing in the examination.
  - c. The list of candidates as given in **Annexure-III**, on re-examination of the rejected list, were found to be eligible for appearing in the examination.
  - d. The list of candidates as given in **Annexure-IV** were earlier issued admit cards and on re-examination were found to be ineligible on various grounds and hence are rejected.
- 3. Candidates who are now approved and included in the verified list in **Annexure-I & III** can download their admit cards from the official website of the Department <a href="https://www.manipureducation.gov.in">www.manipureducation.gov.in</a> and <a href="https://www.manipureducation.gov.in">www.edusmaniregistration.com</a>. However, their eligibility is provisional and engagement is subject to further verification of documents.
- 4. Further, applicants whose status were found verified earlier and now listed in the rejected list as Annexure-IV are forfeited of their candidature. Therefore, the earlier allotted roll number and admit card stands cancelled and are no longer valid for appearing in the forthcoming examination for the post of Graduate Teacher.
