**ORDERS BY THE GOVERNOR: MANIPUR**

Imphal, the 15<sup>th</sup> October, 2021.

No. 29/53/2019-SE(S)Misc-Pt: In supersession of all previous orders issued in this regard, **533** (Five hundred thirty-three) teachers of the Department, as detailed at **Annexure-A**, are hereby transferred and posted at the schools indicated against each of their names under the School Fagathansi Mission.


2. Services in respect of **427** (Four hundred twenty-seven) teachers of the Department, as detailed at **Annexure-B**, are hereby utilized at the schools indicated against each of their names under the School Fagathansi Mission.

3. The teachers transferred & posted/ utilized, as detailed at **Annexures A & B**, shall submit their joining report to the concerned head of the schools on or before the 25<sup>th</sup> October, 2021 without fail with copies endorsed to the Director of Education(S), Manipur at Lamphelpat and concerned Zonal Education Officers.

4. However, the joining letters in respect of the teachers whose orders of transfer/ utilization under 'School Fagathansi Mission' were issued earlier in November & December, 2019 by Directorate of Education(S), Lamphelpat need not be submitted again.

5. The duration of posting (both for transfer and utilization) of these teachers shall be a minimum of 3 (three) academic years starting from the 2020 session/ effective date of orders wherever applicable and continuance in these schools shall be on their performance, commitment and other criteria set by the Department for the purpose.

6. Consequent upon their transfer and posting/ utilization of their services, they are hereby deemed to have been released with immediate effect from their present places of posting/ utilization so as to enable them join at the new places of posting/ utilization and for speedy updation in the CMIS database wherever necessary.


7. The teachers who have been on utilization in these schools but not listed in this Order are hereby repatriated to their original places of posting with immediate effect.

8. A separate Order of transfer & posting in respect of the teachers who were posted at these schools but not listed in this present order shall be issued shortly.

9. Concerned Principals/ Head of Institutions/ DDOs shall prepare pay & allowances of the teachers listed at **Annexure-A** of this Order along with the Principals/ Vice-Principals/ Headmasters/ Asst. Headmasters/ non-teaching staff who had been duly posted in these schools vide Orders of the competent authority.

10. The present Order deals with different categories of Graduate Teachers (AGT/SGT/HGT/HSGT etc.) and Primary Teachers (PT/HPT/MT etc.) only. As such, all orders affecting transfer and posting of other categories of posts in these 60 schools like Principals/ Vice-Principals/ Headmasters/ Asst. Headmasters/ Lecturers/ non-teaching staff etc. shall continue to stand.
