No. 17/1/1-259/21-DE(S): Whereas, the "**School Fagathansi Mission**" was initially introduced in the State in 60 (sixty) schools for each Assembly Constituency to give thrust towards improvement of Government schools, both in terms of physical and manpower infrastructures and performance of students towards learning outcomes.

2. Whereas, the Department assessed the basic infrastructural gaps and funds have been credited in full (*without deducting 1% Labor Cess at source*) in the respective bank accounts of School Fagathansi Mission Management Committees in 2/ 3 installments during 2020-21 & 2021-22 for taking up the works identified and estimated for each of the schools.

3. Whereas, the undersigned had instructed the heads of schools covered under the **1st Phase of School Fagathansi Mission** in various review meetings to maintain adequate balance in the dedicated bank accounts of School Fagathansi Mission Management Committees for future deposit of 1% Labor Cess in relevant deposit heads.

4. Now, therefore, all the heads of schools covered under the 1st Phase of School Fagathansi Mission are advised to deposit the amount of 1% of the total fund released as Labor Cess in favour of the "**Manipur Building and other Construction Workers Welfare Board**" in either of the following bank accounts:
