No. AO/16/SLP/2009(7)-DE(S)Pt-1: Whereas, a tentative inter-se-seniority list of **5673**-elementary teachers who are serving Under Matriculate/Matriculate/Under Graduate/ Primary/Hindi Primary/Hindi Matriculate Teachers (both Original & Converted group) in the Department of Education(S), Manipur has been notified for claims and objections from all the concerned teacher on or before 25-04-2022 vide this office notification of even number dated **07-04-2022**.

2. Whereas, 6 (six) teachers who were not included in the earlier notification of tentative inter-se seniority list issued vide this office notification of even number dated 07-04-2022 claimed for inclusion in the seniority list. Accordingly, they are also inserted in the inter-se seniority list at the proper places of their seniority position based on their effective date of appointment and date of appointment.

3. Whereas, this Directorate disposed of all the claims and objections in the tentative inter-se seniority list which were received by this office after due examination vide this Directorate Notification of even number dated **10-06-2022**.

4. Whereas, **233 (two hundred thirty-three) teachers** have also been excluded from the tentative inter-se seniority list vide this Directorate Notification of even number dated **10-06-2022** due to retirement/resignation/attaining the age of superannuation.

5. Now, therefore, after due consideration and examination of the documents received in this regard, the final inter-se seniority list of **5446 (five thousand four hundred forty-six) teachers** who are serving Under Matriculate/Matriculate/Under Graduate/ Primary/ Hindi Primary/Hindi Matriculate Teachers (both Original & Converted group) in the Department of Education(S), Manipur is hereby notified as detailed in the enclosed **Annexure**.

6. It is further notified that if any genuine claimant is found left out inadvertently the same will be inserted in the appropriate places after due process by issuing separate Orders/Notification as the case may be. And, the final seniority of those teachers whose serial numbers are from Sl. No. **3645 to 5446** in the final inter-se seniority list will be based on the outcomes of the Hon'ble High Court's order relating to **W.P.(C) No. 16 of 2022**.
