**Subject: Acquiring of minimum qualifications by the teachers as per Section 23(1) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009 and information on the number of untrained teachers in Government Schools and in private schools**

Madam/Sir,

As you are aware that the Section 23(2) of the RTE Act, 2009 provides for the deadline of 31<sup>st</sup> March, 2019 for acquiring minimum qualifications for a teacher, who, does not possess minimum qualifications as laid down under Section 23(1) of the RTE Act, 2009. It has been reported by some States/UTs that untrained teachers still exist at the elementary stage.

2. In order to formulate strategy to train all in-service untrained teachers in Government Schools and in private schools, data on the number of untrained teachers is required.

3. You are, therefore, requested to provide us the relevant details for your State/UT in the format attached. Kindly provide these details by 31<sup>st</sup> July, 2022 as this matter is urgent and time-bound.
