Subject: Tentative eligible list of 2687 (two thousand six hundred and eighty seven) Teachers who are serving as Under Matriculate/ Matriculate/Under-Graduate/ Primary/ Hindi Primary Teachers/Hindi Matriculate Teachers (both Original & Converted group) for promotion to the post of Graduate Teachers in the Department of Education(S), Manipur.

No: A0/156/PPT/2011(6)-DE(S)Vol I: Whereas, final inter-se-seniority list of **5457 (five thousand four hundred fifty-seven)** Elementary Teachers who are serving as Under Matriculate/ Matriculate/Under-Graduate/Primary/Hindi Primary Teachers/Hindi Matriculate Teachers (both Original & Converted group) in the Department of Education(S), Manipur has been issued vide this office Notification No. A0/16/SLP/2009(7)-DE(S)Pt-1 dated 13-06-2022 and its corrigendum orders dated 26-07-2022 & 21-09-2022.

2. Whereas, the final seniority position of the Elementary Teachers whose serial numbers are from **Sl. No. 3647 to 5457** in the final inter-se-seniority list notified on 13-06-2022 will be based on the outcomes of the Hon'ble High Court's order relating to W.P.(C) No. 16 of 2022.

3. Now, in pursuance of the approval conveyed by the Government vide their letter No.SM3-501/1/2022-EDN(S)-EDN(S) dated 13/10/2022 a tentative eligible list of **2687 (two thousand six hundred and eighty-seven)** Elementary Teachers who are serving as Under Matriculate/Matriculate/Under-Graduate/Primary/Hindi Primary /Hindi Matriculate Teachers (both Original & Converted group) for promotion to the post of Graduate Teachers in the Department of Education(S), Manipur is hereby notified in two categories i.e (i) Those who posses B.Ed as professional qualification and (ii) Those who posses only D.El.Ed as professional qualification as detailed in the enclosed **ANNEXURE-A** and **ANNEXURE-B** respectively. Those teachers who are found ineligible is enclosed as **ANNEXURE-C**.

4. Those teachers who are not included in the tentative eligible list, may submit their claims & objections along with relevant documents (i.e., Graduate Certificate & Mark-sheet etc. / NOC if necessary) at **Room No. 14** of this Directorate on or **before 28-10-2022 (Friday)** without fail and further claims & objections shall not be entertained after the permissible period.

5. It is also further notified that:


- (a) Those teachers who have passed Graduate/**Post Graduate** with at least 50% marks with B.ED

- (b) Those teachers belonging to SC, ST, OBC and PWD who have passed Graduate with at least 45% marks with B.Ed.
- (c) Those in-service teachers who were admitted for B.Ed. course before 29/7/2011 irrespective of their marks in graduation.
- (d) Those teachers who passed graduation in Home Science and
- (e) Those teachers who have passed graduation and D.El.Ed or equivalent.

should submit their claims along with relevant documents for inclusion in the eligibility list on or before 28/10/2022..

6. Those teachers who have passed the BTC/Sr.BT/Jr.BT/CTEd/CPE/CETED/ DIET/HTCE/HTC should submit their trained scale order, within the above permissible period failing which they may be removed from the eligibility list.
