
- No. AO/271/Rct-PT/2022-DE(S): In pursuance of the Government convey Letters No.SM3-301/2/2022-EDN(S)-EDN(S) dated 14<sup>th</sup> October, 2022 and 17<sup>th</sup> October, 2022, applications are invited from the intending and eligible candidates possessing qualification as per NCTE guidelines for minimum qualification of teachers, for engagement of 1000 Primary Teachers on contract basis.
2. The engagement shall be purely on Contract Basis for the period from the date of contract agreement upto the closing of the financial year as per regulation prescribed by the Government and extendable from time to time with the approval of the Government.
  3. The candidates shall possess the minimum educational and training qualifications as prescribed by the NCTE prevailing on the date of publication of recruitment notification. Relevant portion is enclosed herewith as **ANNEXURE**.
  4. Candidates who are in the last year for the final D.El.Ed./B.Ed examination will be given opportunity to participate in the recruitment process provided they are eligible in all respects except B.Ed./D.El.Ed.
  5. They shall be paid a remuneration of Rs.14,600/- per month.
  6. Reservation quota for the candidates belonging to Scheduled Caste (SC), Scheduled Tribe (ST), OBC (M, MP and others), PWD, Meritorious Sports person shall be maintained as per rules.
  7. The age limit for the candidates shall be 18-41 years (after incorporating the upper age limit by three years as approved by the State Cabinet) as on the date of publication of recruitment notification. Further age limit shall be relaxed by 3 years for OBC Candidates and 5 years for ST/SC Candidates. For PWD Candidates also, additional relaxation as permissible shall apply.
  8. Mode of selection, Date, Time and Scheme of Examination will be notified separately in the Department's Official Website [www.manipureducation.gov.in](http://www.manipureducation.gov.in).
  9. Willing and eligible candidate should be sponsored by the concerned Employment Exchange Offices so as to reach the office of the undersigned on or before Thursday the 17<sup>th</sup> November, 2022.
  10. Date of submission of duly filled in application form along with relevant documents duly attested/self-attested and application fees of Rs.500/ for General and OBC, Rs.300/- for SC and ST shall be notified shortly. Application fees for PWD candidates will be exempted. However, supporting certificates should be attached.



11. The number of posts may increase or decrease as per requirement and other assessment by the Government.

**Minimum Essential Qualifications as per NCTE Norms:**

- (a) Senior Secondary (or its equivalent) with at least 50% marks and 2-year Diploma in Elementary Education (by whatever name known)
- or
- Senior Secondary (or its equivalent) with at least 45% marks and 2-year Diploma in Elementary Education (by whatever name known), in accordance with NCTE (Recognition Norms and Procedure), Regulations- 2002.
- or
- Senior Secondary (or its equivalent) with at least 50% marks and 4-years Bachelor of Elementary Education (B.El.Ed.)
- or
- Senior Secondary (or its equivalent) with at least 50% marks and 2-years Diploma in Education (Special Education)
- or
- Graduation and two-year Diploma in Elementary Education (by whatever name known)
- or
- Graduation with at least 50% marks and Bachelor of Education (B.Ed.)
- or
- Post Gradation with a minimum 55% marks or equivalent grade and three-year integrated B.Ed-M.Ed.
- and
- (b) Pass in Teacher Eligibility Test (TET), to be conducted by the appropriate Government in accordance with the guidelines framed by the NCTE for the purpose.

**Training to be undergone (As per NCTE norms):** A person-

- (a) With Graduation with at least 50% marks and B.Ed. qualification or with at least 45% marks and 1-year Bachelor in Education (B.Ed.) in accordance with NCTE (Recognition norms and procedure) Regulations issued from time to time in this regard, shall also be eligible for appointment to Class-I to V upto 1<sup>st</sup> January, 2012, provided he/she undergoes, after appointment, an NCTE recognised 6-months Special Programme in Elementary Education;
- (b) With D.Ed (special Education) or B.Ed (special Education) qualification shall undergo, after appointment an NCTE recognised Special Programme in Elementary Education;
- (c) Who has acquired the qualification of three year integrated B.Ed-M.Ed from any National Council for Teacher Education recognised institution shall be considered for appointment as a teacher in Classes I to V:  
Provided that the person so appointed as a teacher shall mandatorily undergo a six-month Bridge course in Elementary Education recognised by the National Council for Teacher Education, within two years of such appointment as primary Teacher.

**Reservation Policy:** Relaxation upto 5% qualifying marks shall be allowed to the candidates belonging to reserved categories such as SC/ST/OBC/PH.

No. AO/272/TET/2022-DE(S): As per the approval of the Government in its convey letter No. 12(HC)/140/2022-SE(S), dated 13<sup>th</sup> December, 2022 it is to clarify for information of all concerned that the provisions of NCTE pertaining to in-service Government teachers as per guidelines/norms notified from time to time by National Council for Teacher Education (NCTE) are as follows:

- i) As per para No. 4 of the Notification F. No. 61-03/20-2010/NCTE (N&S) dated 23/08/2010 issued by NCTE, those in-service Under Matriculate/Matriculate/Under Graduate/ Primary Teachers who were appointed prior to the issuance of the above Notification need not acquire/pass TET Paper-I.
- ii) As per para No. 5 of the Notification F. No. 61-03/20-2010/NCTE(N&S) dated 23/08/2010 issued by NCTE, those in-service Under Matriculate/ Matriculate/ Under Graduate/ Primary Teachers for whom advertisement for appointment were made prior to the date of the above Notification need not acquire/ pass TET Paper-I.
- iii) As per para No. 5(b) of the Notification F. No. 61-1/2011/NCTE(N&S) dated 29/07/2011 issued by NCTE, the NCTE Regulation dated 3<sup>rd</sup> November, 2001 (as amended from time to time) shall be applicable for Physical Education Teachers. And the teachers of Art Education, Craft Education, Home Science, Work Education etc. the existing norms prescribed by the State Government shall be applicable till such time the NCTE lays down the minimum qualifications in respect of such teachers.
- iv) As per para No. 4(b) of the Notification F. No-62-1/2012/NCTE(N&S) dated 12/11/2014 issued by NCTE, those in-service Under Matriculate/ Matriculate/ Under Graduate/ Primary teachers who desires to get promoted to the next level i.e. for teaching Classes VI- VIII shall need to acquire TET Paper-II conducted by a competent Government authority.

In view of the above, those in-service government teachers who are required to pass TET Paper-II as per the above criteria shall be allowed to appear in TET, 2022.
