**ADDENDUM**

No. 46/52/2010-ED(V)Pt-I: Whereas, the Final seniority List of Eligible Graduate Teachers appointed before 1/1/2008 holding Master's Degree with 50% marks with B.Ed in any of the 23(twenty-three) subjects concerned as per RR Notification dated 2/12/2021 was notified vide this office Notification of even number dated 30<sup>th</sup> August 2024.

2. Whereas, one Gaichamdinpou Pamei, EIN-066879, SGT, of Khangsilling Hr./Sec, Khoupum, Date of initial appointment dated 19/4/2007 in the grade is incorporated in the said Final Seniority List of Eligible Graduate Teachers appointed before 1/1/2008 between Gangmei Aguna Rongmei and R.K. Leishisan appearing at Sl. No. 45 and 46 as **45(a)** vide addendum of even number dated 9/9/2024.

Whereas, the said Notification of even number dated 30<sup>th</sup> August 2024 has been stayed relating to WP(C) No. 652 of 2024 with MC(WP(C) No. 544 of 2024 vide letter No. 102/322(K)/2024-GA(C)/1726-F dated 17/9/2024, however judgment and Orders passed by the Hon'ble High Court of Manipur, WP(C) No. 652 of 2024 is vacated vide letter No. 102/322(K)/2024-GA(C)/1237-F dated 6/8/2025 and Court relief state that State Government may expedite the process for promotion in terms of seniority list dated 30/08/2024 for the eligible Graduate Teachers appointed before 01/01/2008.

4. Whereas, during the pendency of stay order of the said Notification of even number dated 30<sup>th</sup> August 2024, another 4(four) more claims for inclusion in the said eligibility list was received from the following 4(four) Graduate Teachers;
