Subject:- Submission of fund proposal for payment of arrear of Enhanced Scale in respect of eligible employees.

Sir/Madam,

With reference to the above cited subject, I am to state that this Directorate's Order No. 18/3/2013-ED(S) Vol-II dated 28/04/2026 regarding the grant of Enhanced Scale to 333 employees (Graduate Teacher/Primary Teacher/Hindi Matriculate /Driver) under the Department of Education (S), Manipur has been issued. In this connection, all concerned Drawing & Disbursing Officers (DDOs) are hereby requested to submit fund proposals for drawal of pay/arrears under the Enhanced Scale in respect of the employees under their establishment for the period indicated in the order against their names, from the effective date.

The fund proposal should be submitted in complete shape along with the following documents for necessary action:


1. Statement of Fund Proposal.
2. Statement showing already drawn pay and pay to be drawn after pay fixation.
3. Pay Fixation Statement duly signed by the competent authority/DDO.
4. Xerox copy of Service Book duly attested by concerned DDO.
5. Copy of the Enhanced Scale Order issued by this Directorate of Education(S).
6. Any other supporting documents, if required for verification of eligibility and fixation.

All DDOs are instructed to ensure that proposals are submitted only in respect of eligible employees whose names appear in the approved order/annexure. Pay fixation must be done strictly as per relevant ROPs / Finance Department instructions and the terms of the order. The proposal should be properly checked and verified before submission to avoid delay in release of funds. Any discrepancy found in service particulars, pay drawn, or fixation shall be the responsibility of the concerned DDO. **Further, no arrear/pay relating to the Enhanced Scale shall be drawn or allowed by the concerned DDO until funds are allocated by the Department for the specific employee.**

You are therefore requested to submit the above proposal to the undersigned i.e. Room No. 48 on or before **30th May, 2026** for further necessary action.

This may be treated as most urgent.
