NOTIFICATION

No. AO/272/TET/2022-DE(S)Pt-I: In continuation of this Directorate's Notification of even number dated 27th July, 2026, regarding the conduct of the **Teachers Eligibility Test (TET), 2026 (Paper-I and Paper-II)**, it is hereby notified that the Directorate has scrutinised and examined the applications submitted online within the prescribed timeline.

2. As a result of the scrutiny, **1,539** (One thousand Five Hundred Thirty-Nine) applications for **TET Paper-I** and **800** (Eight Hundred) applications for **TET Paper-II** have been placed under "**Rejected**" status on various grounds as indicated in **Annexure-I** and **Annexure-II** respectively.

3. The applicants whose applications have been placed under "Rejected" status, as indicated in the respective Annexures, may submit their claims and objections, along with relevant supporting documents, if any, for consideration by the Directorate on or before **8th September, 2026**.

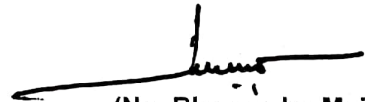
4. Claims and objections received after the stipulated date, i.e. 8th September, 2026, shall not be entertained under any circumstances. Submission of a claim or objection shall not, by itself, confer any right upon the applicant to appear in the TET, 2026, unless the application is subsequently found eligible and approved by the competent authority.

5. All candidates whose applications are found eligible shall be required to exercise their preference for the district in which they intend to appear for the TET, 2026, from among the districts in which examination centres are proposed to be established.

6. Candidates shall exercise their district preference through the link provided in the official website of the Directorate of Education (S), Government of Manipur, www.manipureducation.gov.in, or directly through the link www.tet2026manedus.com, by logging in with the registered mobile number used at the time of submission of the online application by **11th September, 2026**.

7. Candidates who fail to exercise their district preference within the prescribed period shall be allotted an examination centre on the basis of the district of their present address furnished in the application form, subject to availability of examination centres or at the discretion of the Department subject to other administrative considerations and prevailing law-and-order conditions.

8. The candidates are advised to visit regularly the official website of the Directorate of Education (S), Government of Manipur, for further notifications, instructions and updates relating to the conduct of **TET, 2026**.
