No.AO/272/TET/2022-DE(S)Pt-I:In continuation of this Directorate's Notification of even number dated 28th August, 2026, regarding the conduct of the Teachers Eligibility Test (TET), 2026 (Paper-I and Paper-II), it is hereby notified that the Directorate has reviewed the applications accepted in the previous notification dated 28th August, 2026 and scrutinised and examined all claims and objections of rejected applicants submitted within the prescribed timeline.

2. As a result of the review and scrutiny, **9601 applications for TET Paper-I and 15175 applications for TET Paper-II** have been accepted. **101 applications for TET Paper-I and 52 applications for TET Paper-II** have been accepted provisionally. The list of provisionally accepted applicants for TET-I and TET-II are detailed at **ANNEXURE-I** and **ANNEXURE-II** respectively. **875 applications for TET Paper-I and 319 applications for TET Paper-II** are rejected. The list of rejected applicants for TET-I and TET-II are detailed at **Annexure-III** and **Annexure-IV** respectively.

3. All eligible candidates shall require to exercise their preference for the district in which they intend to appear for the TET, 2026, from among the districts in which examination centres are proposed to be established.

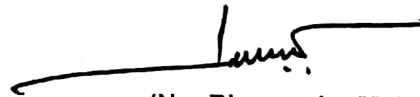
4. Candidates shall exercise their district preference through the link provided in the official website of the Directorate of Education (S), Government of Manipur, www.manipureducation.gov.in, or directly through the link www.tet2026manedus.com by logging in with the registered mobile number used at the time of submission of the online application by **20th September, 2026**.

5. Candidates who fail to exercise their district preference within the prescribed period shall be allotted an examination centre on the basis of the district of their present address furnished in the application form, subject to availability of examination centres or at the discretion of the Department subject to other administrative considerations and prevailing law-and-order conditions.

6. Accepted PWD (Visually Impaired and Orthopedically Handicap) applicants who are willing to avail the personal Scribe are to furnish duly filled-in "Declarations by the Candidate and Scribe" appended herewith as **ANNEXURE-V** to the office of the undersigned on or before **20th September, 2026**.

7. All eligible candidates shall be allowed to download their admit cards through the link provided in the official website of the Directorate of Education (S), Government of Manipur, www.manipureducation.gov.in, or directly through the link www.tet2026manedus.com, by logging in with the registered mobile number used at the time of submission of the online application with effect from **17th September, 2026**.

8. The candidates are advised to visit regularly the official website of the Directorate of Education (S), Government of Manipur, for further notifications, instructions and updates relating to the conduct of TET, 2026.
